

Upon entering and parking at Valentine Sports Park (VSP) you agree to enter into a contract with Football NSW Limited (FNSW).

If you do not accept these terms and conditions of entry, you must leave the venue immediately. Entering and remaining at the venue will constitute acceptance of the following terms and conditions of entry;

COVID-19 Conditions of Entry

All visitors must:

1. Confirm that they are well and must not have experienced cold or flu symptoms in the last 14 days, not have returned from overseas or any known case location as listed on the NSW Health website <https://www.nsw.gov.au/covid-19/latest-news-and-updates> in the last 14 days.
2. Upon entry to the venue, scan the Services NSW QR Code using a mobile phone camera, register contact details and follow the prompts. These details will be used in accordance with the COVID Safe Check-in – Privacy Collection Statement <https://www.service.nsw.gov.au/covid-safe-check-privacy-collection-statement>
3. Observe COVID-19 information signage and staff advice in relation to seating, movement through the venue, capacity limits and entry and exit points to ensure physical distancing from others.
4. Maintain a 1.5m distance from others at all times in accordance with public health orders.
5. Practice safe hygiene, including washing their hands regularly with soap and water and using hand sanitiser upon entry and exit.'
6. Spectators should be restricted to essential people only.
7. Face masks are mandatory inside Valentine Café and Advantage Aquatics Swimming Centre, located within Valentine Sports Park. Venue management encourage face masks to be worn at the venue when not participating in a sporting activity.

Visitors who do not comply with these conditions will not be admitted or will be asked to leave to ensure the safety of all.

General Conditions of Entry

1. Speed limits are 10 km per hour at all times no exceptions
2. All visitors MUST adhere to speed limits at all times
3. All visitors MUST adhere to all signs at all times
4. FNSW assumes no liability for loss or damage to any vehicles and/or their contents however caused
5. Football is played on this site and vehicle owners and drivers assume all risk for damage to vehicles caused by footballs
6. VSP Car park is to be used strictly for the clients of Football NSW, Advantage Aquatics, Valentine Café and hirers of the venue
7. No Commuter Parking at any time
8. This is not a public park, this is a private sporting facility, its use is reserved for authorised persons only
9. Access to the dam is prohibited
10. When leaving the car park all users are required to use caution when entering the roundabout
11. Overflow car park IS ONLY TO BE USED when signage indicates that the car park is "OPEN". Service vehicles are exempt with consent if access is required to perform services at the venue
12. Vehicles are not to access at all times "No Access" areas without consent
13. Motel carpark is for motel guests only. Vehicles are not to access Motel car park without consent
14. "Drop off zone" in front of the café IS ONLY TO BE USED when a passenger is alighting from vehicle and NOT for permanent parking
15. "Deliveries / Emergency Vehicle Zone" in front of the concourse IS ONLY TO BE USED for deliveries, no other areas are to be used without consent
16. Vehicles are not permitted to drive on the pedestrian concourse without consent from venue management
17. Smoking is strictly prohibited in the car park and surrounding lands
18. Alcohol is strictly prohibited at this venue

30. Drones are not permitted in the in the venue grounds without consent
31. Flares, fireworks, loudhailers & air horns, instruments prohibited by law, banners or placards displaying political messages or slogans are prohibited in the venue grounds at all times
32. Written permission must be obtained to display any banners or flags around the venue. FNSW reserves the right to remove any flags or banners should they be deemed inappropriate
33. External catering is not permitted anywhere on the grounds without written consent
34. From time to time, we include third party products or services in special packages. We are not liable, under any circumstances, for any failure by third party providers to provide products or services or for any error, alteration or change of any kind made by those third-party providers. All third-party coupons, vouchers, receipts and tickets are issued subject to the terms and conditions specified by those third-party providers.
